It shall be the responsibility of the Anti Ragging Committee to ensure compliance with the provisions of UGC Regulations on Curbing of Menace of Ragging in Higher Educational Institutions 2009 vide F.1-16/2007(CPP-II) dated 17 Jun 2009, as well as the provisions of any law for the time being in force concerning ragging and also to monitor and oversee the performance of the **Anti-Ragging Squads** detailed for prevention of ragging in the Institutions.
- 3. Complying with the directives of the Hon'ble Supreme Court of India (vide its order dated 16 May 2007), AICTE Notification dated 01 Jul 2009 (issued vide F No 37-3/Legal/AICTE/2009) and UGC letter No F.1-15/2009 (ARC) Pt III dated 29 Apr 2014, the above Anti-Ragging Committee is formed for overseeing the implementation of the provisions of the Anti-Ragging verdict (available at www.antiragging.in & www.noragging.com and e-mail helpline@antiragging.in and UGC Anti Ragging Helpline 1800-180-5522 (24X7 toll free) only in case of emergency).
- 4. The Committee comprising faculty members, administrators and women representative will monitor the measures taken by the Institute for prevention of ragging, will look into the specific instances of ragging and complaints of ragging etc, and suggest appropriate actions/punishments against individuals indulged in ragging.
- 5. Meeting of Anti-Ragging Committee will be initiated by Office of Associate Director (SA) during before the commencement of the academic session. The committee will discuss the measures to be taken to prevent ragging in the institution and steps to be taken to identify those indulging in or abetting ragging and punish them.
