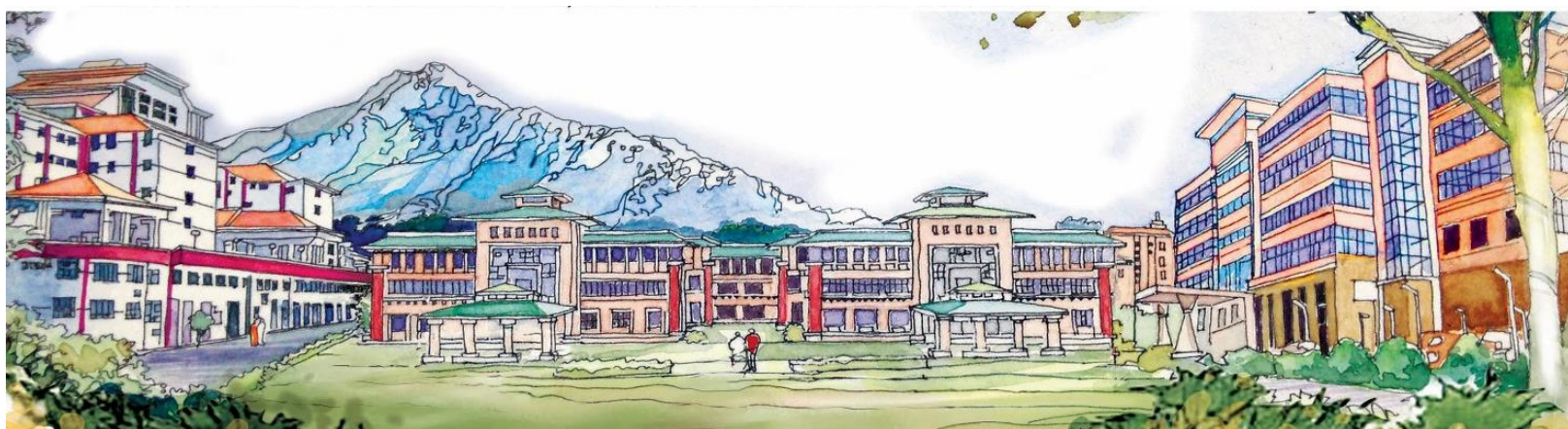

## Privacy Policy

Information we collect

- **Contact information:** We might collect your name, email, mobile number, phone number, street, city, state, pin code, country, and IP address.

- **We get information about you from third parties:** We may get information from the third-party social media site about you. This could include your name, email address, and mobile number.

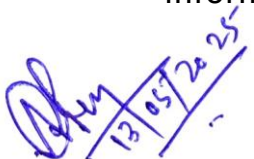

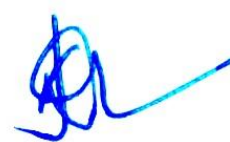

### Use of your personal information

1. We use the information you provide to reach out to you for promotional purposes.

## Cookies

1. A cookie is a small file that asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to patients' needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
2. Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. Cookies do not provide us access to your computer or any information about you, other than the data you choose to share with us. You can choose to accept or decline cookies.
