 - a. The candidates shall deposit the fees prescribed by the University within 15 days from the date of issue of this Office Order, to SMU Account: Name of Account - Sikkim Manipal University, Bank Name & Branch: Canara Bank , 5th Mile, Sikkim, Account No. 8676101002080, ISFC Code: CNRB0008676 and after the submission of the requisite fee receipts, the receipt of payment to be sent to safalta.sharma@smu.edu.in and anieth.subba@smu.edu.in
 - b. The candidates are informed that the allotted registration number and registration for the PhD program at SMU will be confirmed once approved by the Departmental Research Committee (DRC) followed by Institutional Research Committee (IRC) and subsequently by University Research Committee (URC). The DRC and IRC approval must be obtained within one year from the date of announcement of the PhD Entrance Examination results of the candidate. Once approval from IRC is accorded, the registration number will be ratified in URC for confirmation from the date of approval of DRC.

- c. A candidates admitted into all categories of the Research Programme must submit the progress report every six months and will have to register in person annually on the stipulated date. The registration will be renewed annually, on satisfactory progress.
- d. The Scholars listed above must complete their prescribed Ph.D. coursework and IRC Protocol presentation not beyond 15th of January 2026.
- e. It is to be noted that failure to fulfil these requirements within the specified timeline may result in a delay in the registration confirmation or possible implications for the enrolment status of the Scholar.

2. Fee Structure for Ph.D Program, SMU (Only for the First Year of Registration)

- a. For Internal Part Time: Annual Fee Rs.30,000 + One Time Registration Fee Rs.10,000 = Total 40,000/-
- b. For External Part Time: Annual Fee Rs.40,000+ One time Registration Fee Rs.10,000= Total 50,000/-
- c. For Full Time: Annual Fee Rs.30,000 + One Time Registration Fee Rs.10,000 = Total 40,000/-
- d. Please note that the examination fee will be communicated to you on a later date and is subject to change or revision periodically.

- 3. Note: Part time Candidates to refer to Section 5.2 and 5.3 of SMU PhD. Regulation 2024.
 - 5.2 Part Time (Internal) Candidate:
 - 5.2.1. The candidate should furnish a "No Objection Certificate" from the Head of the Department concerned for applying for Ph.D. programme. 5.2.2. Subsequently, candidate should furnish "Sponsorship and No Objection Certificate" from the proposed Supervisor/Co-Supervisor.
 - 5.3 Part Time (External) Candidate:
 - 5.3.1. Supervisor of part time candidate shall be the faculty member of one of the units of SMU. Co- Supervisor(s) may preferably be from the organization / academic institute / industry where he / she is working. 5.3.2. The candidate should furnish a "sponsorship and No Objection Certificate" from his / her parent organization / academic institute / industry.

5.3.4. Candidates admitted under this part time category will be allowed for conversion of his/her candidature to full time within six months from the day of his/her provisional or confirmed registration, whichever is earlier.
